IRS Official Urges Employers to Consider Options, Programs When Classifying Workers

Classifying workers as independent contractors may be a valid business decision in some instances, but these classifications must be based on law, not personal preference, the Internal Revenue Service's Anita Bartels said during an IRS webinar Feb. 15.

Acknowledging the complexity of classification, Bartels said employers can always file Form SS-8 [Determination of Worker Status for Purposes of Federal Employment Taxes and Income Tax Withholding] and "let the IRS determine for you," Bartels said.

It generally takes six months for the Form SS-8 process, she said. An employer does have the right to appeal the determination decision, but the typical appeals process does not apply in this instance as it is not an examination, Bartels said.

Classification usually is based on a common-law test that examines whether an employment relationship exists. A worker is an employee if the employer can control what the worker does, and how the worker does it.

Bartels also addressed the Internal Revenue Code Section 530 safe harbor provision, which allows an employer to treat a worker as an independent contractor for federal employment tax purposes, even though the worker may actually be an employee under the common law rules.

VCSP Available to Employers

She explained that three requirements must be met to obtain safe harbor relief: a reporting consistency, a substantive consistency, and a reasonable basis. Determining eligibility for the safe harbor is the first part of any IRS examination regarding classification.

In addition to the safe harbor provision, Bartels encouraged participants to consider the service's Voluntary Classification Settlement Program announced in September (57 CLR 969, 9/29/11). Under the initiative, employers that prospectively treat their workers as employees can make a minimal payment covering past payroll tax obligations rather than waiting for an IRS audit.

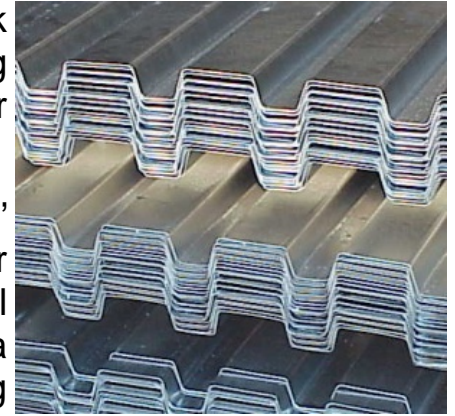

Asbestos Rule changes take effect March 2, 2012 and will affect contractors, landfills, and large projects.

Ohio EPA is announcing changes to Ohio's Asbestos Emission Control regulations will be taking effect as of March 2, 2012. These rules affect contractors, landfills and large projects. The rule changes were implemented to provide clarification and to make the rules consistent with the federal asbestos NESHAP regulations at 40 CFR Part 61, Subpart M. Some of the changes include:

A change to the definition of "small fragments" in Ohio Administrative Code (OAC) rule 3745-20-01. OAC Rule 3745-20-01 now defines "small fragments" as four (4) square inches or less to be friable or regulated asbestos containing material (RACM). Also, large projects involving the renovation/demolition of multiple residential structures are to be considered a "Facility".

OAC Rule 3745-20-05 has been changed to require that all category two material (Cat II) to be disposed at a regulated asbestos landfill.
